## Booking Conditions

- 1. Formation of Contract** A binding contract between the holidaymaker and the owners will be entered into on the Company issuing the holiday confirmation/receipt.
- 2. Deposit Required** £50.00 per week paid at the time of booking, the balance due 28 days before commencement of hire. Please make cheques payable to COCKERHAM SANDS COUNTRY PARK. Holidays booked within 28 days of commencement date, full amount due on booking.
- 3. Balance of Payment** This is due 28 DAYS PRIOR TO THE COMMENCEMENT OF HIRE. If the final payment is not received by this date it will be deemed as a cancellation.
- 4. Cancellation** Any cancellation shall be in writing. On receipt of such notice the Company shall endeavour to re-let the holiday accommodation for the entire period of the original booking. If the Company shall be successful in re-letting the accommodation for the entire period originally booked it shall refund all monies paid less a handling charge of £30:00. No monies will be refunded if the accommodation is only re-let for a proportion of the period originally booked. If cancellation is made within twenty eight days of the holiday date all monies paid by the holiday maker will be forfeited to the Company.
  - 4a.** We strongly advise that holiday cancellation insurance is taken out.
- 5. Full Week Booking** Saturday to Saturday - Commence 4pm on day of arrival and terminate at 10am on day of departure.
- 6. Number of Persons** The number of persons using the holiday accommodation shall not exceed the maximum number stated in the accommodation details.
- 7. Equipment** All necessary utensils, cutlery, duvets pillows and bed linen are supplied. Holidaymakers need only bring tea cloths and towels.
- 8. Personal Effects** All personal effects and property belonging to the holidaymaker shall be left in the accommodation at their own risk.
- 9. Reception Office** The office opens daily from 9am to 5pm. Keys will be left for late arrivals with the warden.
- 10. Alterations** The company shall make every effort to provide the accommodation specified by the holidaymaker but may have to make changes from time to time.
- 11. Repair** The holidaymaker shall keep the holiday accommodation and all furniture, fixtures, fittings and effects in or on the holiday accommodation in the same state of repair and condition as at the commencement of the holiday. The holiday accommodation shall be left in the same state of cleanliness and general order in which it is found.
- 12. Cots** Available only if booked in advance, no charge will be made.
- 13. Pets** Additional charge of £25.00 per week. Maximum of 2 dogs per unit in specific units. Dogs must be kept on a lead at all times.
- 14. Facilities** Subject to seasonal availability.
